Submission Terms and Conditions

***Please read these terms and conditions ("Submission Terms") before submitting the form "Basic Information for New Prescriptive Measure" ("Submission Form") to the Independent Electricity System Operator ("IESO").***

During the term of the Save on Energy Retrofit Program ("Program") offered under the 2021-2024 Conservation and Demand Management Framework, the IESO invites stakeholders and other interested parties to submit suggestions via email to [retrofit@ieso.ca](mailto:retrofit@ieso.ca) for energy efficient equipment and technologies that they wish to have considered for potential inclusion in the Program as a prescriptive measure ("New Measure Submission Process").

By submitting a completed Submission Form and any suggestions, descriptions, details, concepts or ideas, drawings, photographs, and any other related materials of any kind whatsoever submitted in respect of a proposed prescriptive measure (collectively, the "Submission") through IESO's New Measure Submission Process, you acknowledge, understand and agree that the following Submission Terms constitute a binding legal agreement between you and IESO and will apply to your Submission:

1. You represent and warrant that you are at least eighteen (18) years old and your Submission is being submitted on a voluntary and unsolicited basis.
2. You represent and warrant that the Submission is your original creation, does not contain any confidential information or trade secrets, does not violate any intellectual property rights, privacy rights or the rights of any third party, and is not otherwise unlawful.
3. Your Submission will become the property of IESO and will not be treated as confidential or be subject to any obligation of confidentiality by IESO or any third or other party with whom IESO may share the Submission.
4. IESO has the right to retain, use and disclose your Submission for any purpose, without any credit or compensation to you or any third or other party.
5. IESO makes no commitment, and is under no obligation, to review, accept, or otherwise use your Submission, or include the proposed prescriptive measure described in your Submission in the Program. The receipt, review, acceptance, or other use of the Submission by IESO, or any invitation by IESO to engage in further discussions about your Submission does not constitute an endorsement of any commercial product or person by IESO.
6. IESO may already have independent knowledge of the information submitted as part of your Submission or may receive other submissions through the New Measure Submission Process that are similar or identical in content to your Submission.
7. IESO reserves the right to make any changes to the New Measure Intake Process that it deems necessary in its discretion and without notice.
8. IESO and any third or other party with whom IESO shares the Submission with shall not be liable for any use or disclosure of any information or Submission that you submit through the New Measure Submission Process.
9. You hereby release IESO from any liability arising out of or relating to the receipt or use of your Submission. You agree to indemnify, defend and hold harmless IESO, its successors and assigns, and each of their directors, officers, agents and employees from and against any and all claims, damages, obligations, losses, liabilities, costs, and expenses (including, but not limited to legal fees) arising from: (i) your violation of the Submission Terms; (ii) your violation of any third party right, including without limitation any copyright, intellectual property, or privacy right; or (iii) any claim that your Submission caused damage to a third party. This defense and indemnification obligation will survive the Submission Terms.
10. These Submission Terms constitute the entire agreement between you and IESO with respect to your Submission and shall be governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein.
